Dear Members of the Village of Vernon Board,

I am attaching a cost estimate/proposal for the Village of Big Bend Police Department to provide Police Services for the Village of Vernon. I have included a few different options, depending on what your Village would prefer. The upper portion shows the cost breakdown, with the total costs for each option at the bottom.

I have included different options such one shift per day for five days a week and one shift per day for seven days per week. In addition, I have included options for a brand-new squad car, and also one for the Village of Big Bend Police Department providing one of our current squads, a 2023 Ford Police Interceptor Utility (Explorer) that would be dedicated to patrolling the Village of Vernon, and could have the graphics replaced to have the Village of Vernon on it, should you so desire. The if the option to use the Big Bend squad, were to be chosen, the vehicle and equipment would remain the property of the Village of Big Bend, but would be the dedicated Village of Vernon for the duration of the contact.

The estimate is for 2026 and based on the Officer's current contract which goes through the end of 2027, and current costs for items.

Additionally, the Officer would need workspace with security in compliance with Criminal Justice Information Security (CJIS) which could be provided by the Village of Vernon, or they could use the Big Bend Police Department, whichever option you prefer.
